

# **Apprentice Track Guidelines**April 2015

These decisions were made by the RCOM pertaining to the **Apprentice Track** path to candidacy for ordination in the CCSW.

- The Educational requirements will be a **minimum** of 700 contact hours. A contact hour is 50 minutes of instruction, either face to face or an online setting. All contact hours must be documented by the source of the class. This determination was made based upon a comparison to an MDiv degree and completing education in each of the required 16 areas of ministerial practice. Please note: the apprentice track will most likely take much longer to complete than the seminary track.
- Candidates who are asking to be considered on the Apprentice Track must qualify in one or more of the 4 areas (financial, vocational, familial and linguistic see requirements below). Candidates will complete the Personal Data form, Candidacy form and an Additional Apprentice Track Data Form as the initial paper work.
- A subcommittee of RCOM will read the Apprentice Track applications prior to scheduling any appointment. If they have questions, they will contact the potential candidate and Area Minister (AM) to clarify. Upon approval of the paperwork, an initial interview will be held at the next scheduled RCOM meeting. (RCOM meetings occur in January, April and September.)
- In the initial meeting with the Area Minister (AM), required of all candidates, the Area Minister will share the 4 criteria areas and emphasize that the preferred education track is MDiv. The AM may also be able to offer directions toward various MDiv possibilities that could meet his/her needs.
- **Meeting the criteria.** The area(s) in which the candidate claims as a reason for this application are to be described in detail. Some may require additional documentation. These criteria are listed below:

#### **VOCATIONAL**

You may qualify for the apprentice track for vocational reasons, if your current employment precludes you from being able to attend seminary, either in person or online. (Ex: You work overseas as a government contractor on an irregular schedule which would impede regular class schedules)

### FINANCIAL/ECONOMIC

You may qualify for the apprentice track for financial/economic reasons, if your debt to income ratio is so great that you cannot take on more debt for a seminary education. Documentation required: Last tax return and other financial information such as student loans, medical expenses, etc. that would impact your educational path.

#### **FAMILIAL**

You may qualify for the apprentice track for familial reasons. (Ex: You have a child with a disability for whom you provide the majority of care, and whose health would be compromised by relocation or by a change in care)

#### LINGUISTIC

You may qualify for the apprentice track for linguistic reasons, if you are unable to find an accredited seminary program that reflects DOC ethos (face to face or online) in your primary language.

As with all candidates for ordination, one's educational preparedness will be measured in the candidate's ability to demonstrate competency in the 16 areas of ministerial practice.
